REAL TIME MARKET DATA SUBSCRIPTION SERVICE

At ECOMMBX Investments, all equity trades are executed using official market data directly from global stock exchanges. To access and trade on live market prices, clients may subscribe to the relevant exchanges of their choice.

CURRENCY CONVERSION FEE

When you convert funds from one currency account to another or when you trade an instrument in a currency that differs from your base account denomination, conversions, including trading profits/losses, are executed using the FX rates with markups as below:

- EURUSD up to 0.35%
- EURGBP up to 0.35%
- USDGBP up to 0.35%

CUSTODY FEES

Custody fees apply in accounts with stocks, ETFs and bond positions. The annual custody fee will be calculated daily on the average portfolio value and charged on a monthly basis.

MANUAL ORDER FEE

Orders placed by clients via phone, chat, or email will incur a manual handling fee of EUR 50 per order. Certain products that are unavailable on the platform may be exempt from this fee.

REPORTING FEE

For clients on the Classic service level, a fee of EUR 50 (or the equivalent in the account currency) will be charged when reports available online are requested to be delivered by email. The same fee will apply to third party requests for such reports, for example from auditors.

TERMINATED ACCOUNT ADMIN FEE

If a client fails to withdraw all cash from their account before the termination date set by ECOMMBX, a fixed administration fee of up to EUR 15 per month (or the equivalent in the account currency) will be applied (please refer to company's General Terms and Conditions).
